

## Surfboard Rental Agreement

I (Renter) hereby state that I am at least 18 years of age. I am renting a surfboard from the Kitesurfwake.com shop and agree to the following terms:

1. The cost of the rental per surfboard is: \_\_\_\_\_ Daily - €20.00 or \_\_\_\_\_ 5 days - €65.00 or \_\_\_\_\_ days - €\_\_\_\_\_
2. Daily rentals must be returned 24 hours from the time of rental.
3. Rentals longer than one day must be returned by **5 pm** on the **last day of the rental period**.
4. The rental does not include a wetsuit – an extra charge of **5 € per day** will be added to the total price if required.
5. The rental does not include wax – an extra charge of 3 € will be added to the total price if required.
6. The rental includes fastening belts for car transportation.
7. The rental does not include insurance – an extra charge of **3 € per day** will be added to the total price if required. Insurance covers valued damage up to 30€, which considers a break of the leash or loss of a fin.
8. Renter's personal information will be only used to guarantee a correct service. The Renter, according to the law, can ask for their access, modification, cancellation, or opposition through any stipulated means of communication.
9. I declare to be in good health conditions required for the practice of this sport. I will always keep in mind our recommendations regarding the level and conditions of the beach.
10. I understand It is totally forbidden to lend, sell or exchange the rented surf equipment.
11. I understand that rented surf equipment must be returned in the same conditions they were given at the time of the pick-up. Otherwise, I will inform the Lessor about any damage. I understand and accept the following replacement costs mentioned in this contract:
  - a. **BOARDS:** Severe deterioration or break, loss, or theft will incur an extra charge of 300€ for any board type. Partial deterioration like wholes, bumps, etc. will be valued and charged according to damage (10 € - 150 €).
  - b. **LEASHES:** Loss or theft will incur an extra charge of 30 €. Slight deterioration - will not incur any extra charge as they are a consequence of regular usage. –
  - c. **FINS:** Break, deterioration or loss, will be valued according to damage (5 € - 30 €).In most cases, replacement of the item will be required.
  - d. **WETSUITS:** Break or important deterioration like zips, theft, or loss will incur in an extra charge of 60 €. Partial deterioration - will not incur in any extra charge as they are a consequence of regular usage.
  - e. **ROOF RACK SYSTEM:** Break or important deterioration, theft or loss will incur in an extra charge of 40 €.
12. I release Kitesurfwake.com, the owners, employees, assigns, and heirs of any liability associated with this surfboard rental.
13. I understand that surfing is an inherently dangerous sport that requires the ability to swim and knowledge of the ocean and rip currents; that this surfboard rental is not a Coast Guard approved

flotation device, that I have inspected this surfboard rental and understand that Kitesurfwake.com shop is in no way liable for my use or misuse of said surfboard rental.

14. Failure to return surfboard rental on time will result in additional charges of an extra day's rental plus a €20.00 late fee.
15. I understand that if, after 24 hours from the declared date of return, I won't return the equipment or inform Kitesurfwake.com about the expected date of return, it will be treated as theft and will be reported to the police.
16. All court costs, resulting from a breach of the obligations stated in this contract will be borne by Me (the Renter).
17. This contract is subject to Portuguese jurisdiction.
